Terms & Conditions

1. The earnest money will have to be deposited online and no interest shall be payable on earnest money.
2. The **Technical Bid** of the tender will be opened on 07.03.2024 at 11.00 A.M and the **Financial Bid** will be opened after evaluation of technical bid.
3. Tender received after the due date and time, incomplete and conditional tender will be rejected straightway.
4. The rates should be quoted in figures as well as in words.
5. Non-compliance of the terms and conditions of auction shall be liable to forfeiture of the security/black-listing of firm for future dealings and such other action as deemed fit.
6. The Punjab Agricultural University reserves the right to reject or accept any or all the tenders without assigning any reason.
7. The bidders shall bid for the whole lot (and not a part thereof) of a particular item at any station.
8. Market fee, sales tax and other levies as applicable, shall be paid by the bidder concerned.
9. The rates quoted should be exclusive of Market fee, GST and other taxes, levies as applicable. These shall be paid by the bidder additionally
10. Bid of tender will be evaluated item wise and order will be placed accordingly.
11. The rates quoted should be valid up to 60 days.
12. The material will be delivered after 100% payment to the successful bidder who gives the highest bid. The final payment will be made through Demand draft, in favor of Comptroller, PAU Ludhiana, at the concerned Farm from where the auctioned material is to be lifted. The earnest money of successful bidder will be returned after completion of the process from the concerned station. The concerned Director of the Farm, will intimate to Admn-cum-Accounts Officer, Store Purchase Organization, PAU, Ludhiana regarding satisfactory completion of process and returning of earnest money.
13. The successful bidder will have to make arrangement for transporting the material after weighment. The farm will have no responsibility of loading, transport etc.
14. Successful bidder will bring his own packing material.
15. The lifting will be allowed after the receipt of full payment. The lifting of the material must be completed within 10 days from the date of acceptance of bid. If due to certain unavoidable circumstances, it is not possible for the farm to deliver the material within stipulated period, the Director of the concerned Farm can enhance the delivery period as may be necessary.
16. In case of non-lifting of auctioned material within the stipulated period, the Earnest Money Deposit will be forfeited.
17. Once the auctioned material has been lifted by the bidder, no complaint about quality of material will be entertained.
18. Quantity of available stock may increase or decrease.
19. In case of any dispute, the Vice Chancellor, PAU, Ludhiana will be the sole authority to resolve the dispute.
20. All disputes subject to Ludhiana Jurisdiction.
21. Bidder should be registered with the Market Committee of the Punjab. The Registration Certificate must be attached.
