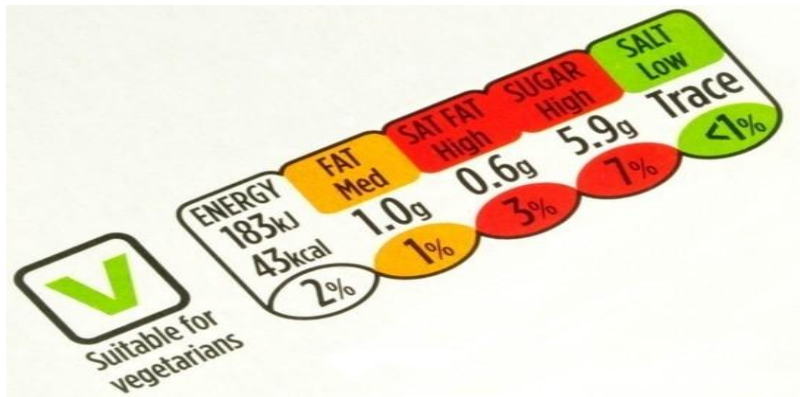


FSSAI New Labelling , Display and Other Regulations for Food Business Operators



Labelling Requirements

The Name of Food: The name of the food shall indicate the true nature of the food contained in the package.

Net Quantity: Net quantity is all about the overall weight of the product or food item. Net quantity comprises product weight along with the weight of the packaging.

List of Ingredients: Except for single ingredient foods, a list of ingredients shall be declared on the label



Nutritional information

Nutritional information is a description intend inform the consumer of nutritional properties food

Nutritional Information per 100g or 100ml product and per serve percentage (%) contribution to RDA

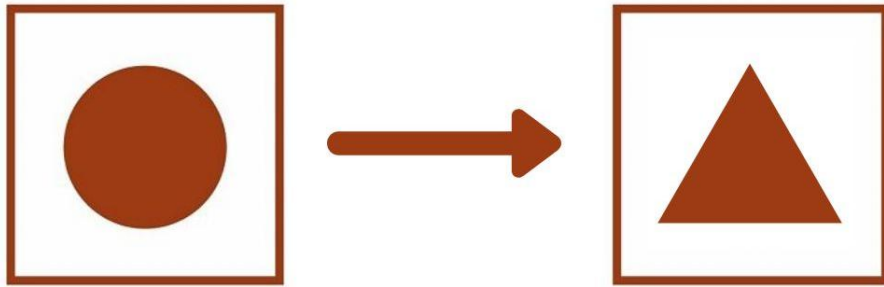

Declaration regarding Food Additives

Food additives are those additional things added to the food in order to preserve the flavor and enhance its appearance as well as taste. Thus, declaring the additives on the package or the level is a mandatory thing.

Food additives are commonly added to food to:

- Increase shelf life
- Enhance flavors
- Reduce the cost of the food item
- Stabilize a product during treatment
- Change the food texture



Name and complete address of the manufacturer

The manufacturer’s name, complete address, and place of manufacturing should be mentioned at a prominent place on the label.

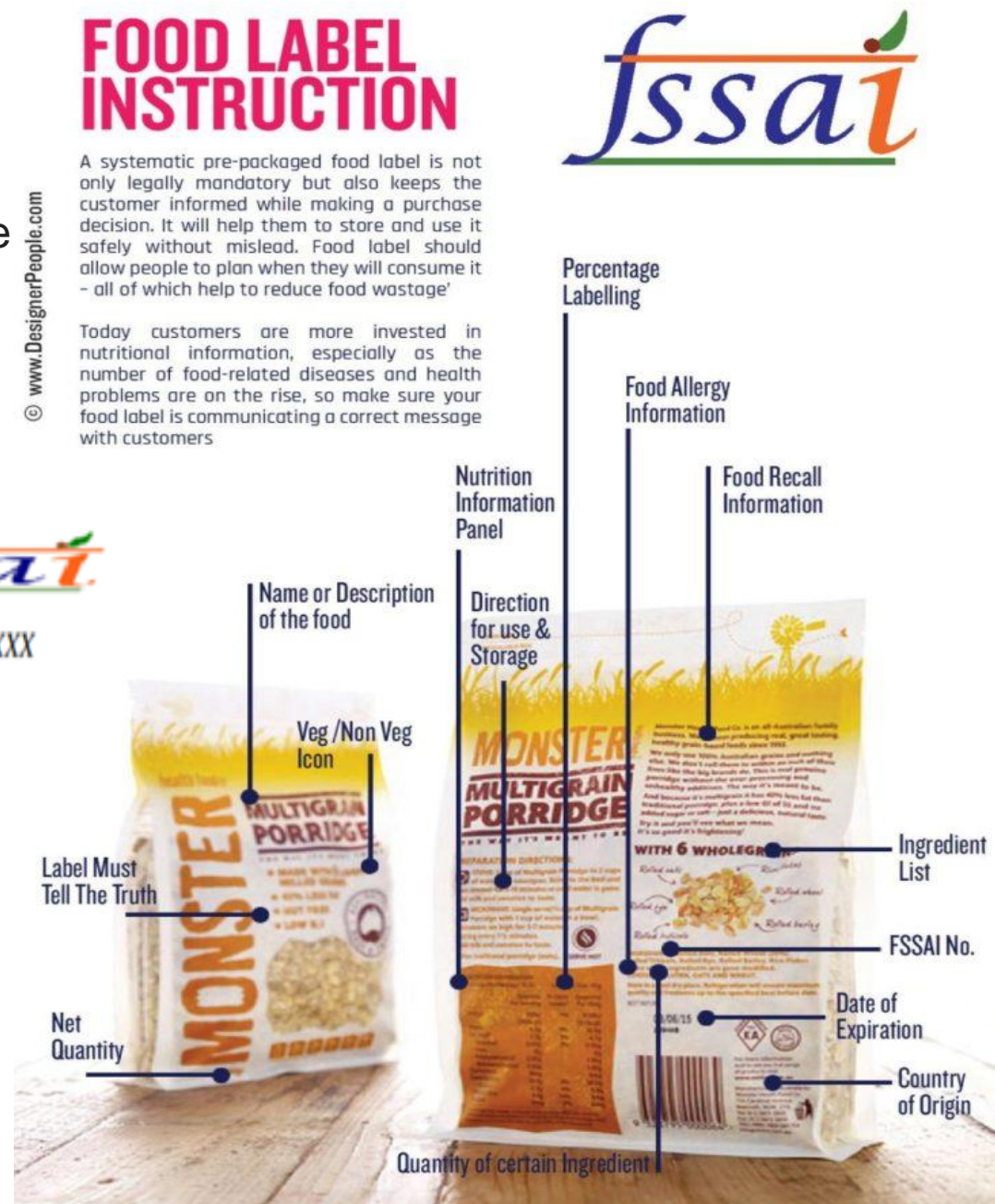
Retail Sale Price

FSSAI logo and license number

As per the FSSAI labelling rules, the FSSAI logo and license number must be mentioned at a prominent place on the label.

Batch no/Code no/lot no

These numbers provide authenticity about the manufacturer of the product and hence should mention on the label.



Manufacturing Date and the Best Before/use-by date

This is an important piece of information for consumers. It will inform them as to when the product must be consumed. Any consumption after the expiry date may cause harm to the consumer.

The day, month and year using the DD/MM/YY format for products

Instructions for use

Instructions for use, including reconstitution, where applicable, shall be included on the label, to ensure proper utilization of the food or where such food requires directions for reasons for health and safety (e.g. 'Refrigerate after opening').

Information relating to allergens

Peanuts, tree nuts and their products



FSSAI launched Food Safety Compliance System (FoSCoS) wef 1st June 2020 replacing existing Food Licensing and Registration System

FSSAI is a legal body that delivers a food license to all food business in India

WHAT IS FSSAI?

FSSAI = Food Safety and Standards Authority of India



Food Safety and Standards Authority of India (FSSAI) is an autonomous statutory body established under the Food Safety and Standards Act, 2006. Ministry of Health & Family Welfare, Government of India, are the administrative Ministry of FSSAI.

FSSAI establish the standards and practices, It protects and promotes public health through supervision and regulation of food safety.

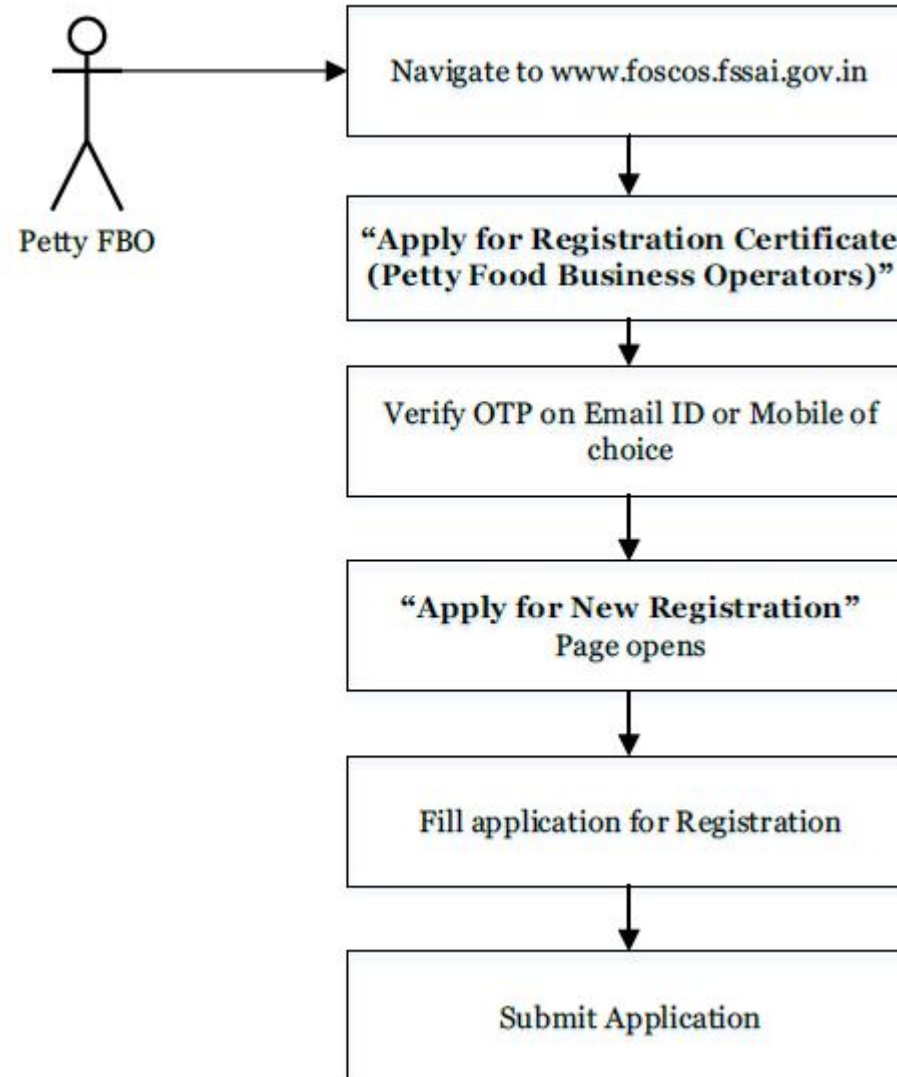

FOOD TESTING

Food Testing and analysis is an essential part of the food safety ecosystem to assure that the food is safe to consume.

For the same, FSSAI recognizes and notifies NABL accredited food laboratories under Section 43 of FSS Act, 2006.

FSSAI is also recognizing foreign laboratories to reduce the time in clearance of food consignments at ports.

FSSAI approved notified laboratories as National Reference Laboratories (NRLs) and as ancillary facility of NRLs (ANRLs) for specific purpose.

1. Primary food laboratories

The Food Authority notifies food laboratories and research institutions accredited by National Accreditation Board for Testing and Calibration Laboratories or any other accreditation agency for the purposes of carrying out analysis of samples by the Food Analysts.

Presently there are 190 notified food testing laboratories.

3. National Reference Laboratories

FSSAI has recognized National Reference laboratory (NRL) to set up a country wide standard for routine procedures, validation of such standard procedure / testing methods, development of new methods and ensuring proficiency in testing across the food laboratories with special reference to the risks or food categories.

Either a primary food laboratory or a referral food laboratory can be considered for declaration as a NRL.

Presently there are 12 NRLs and 2 ANRLs.

The Food Authority recognizes referral food laboratories for the purposes of carrying out analysis of appeal samples.
