**1. INTRODUCTION**

- a. The PAU has played a key role in increasing food grain production in the Punjab State by developing improved varieties/ hybrids and their dissemination from lab to field.
- b. The University also serves the farmers by providing quality seed of improved varieties/ hybrids of different field and vegetable crop to the farmers during kisan melas and around the year at seed shops and seed outlet centres at KVKs, FASCs, RRSs and USFs in various districts of Punjab.
- c. Punjab Agricultural University, Ludhiana (PAU) intends to increase the production of seed of maize hybrids PMH 14 and PMH-17 so as to make available the quality seed of this hybrid to large number of farmers.
- d. The purpose of this Expression of Interest is, therefore, to seek the services of a seed producer having expertise in maize cultivation/ seed production. The objective of this document is to provide information about the scope and objective of this activity.

- a) Punjab Agricultural University invites expression of interest from seed growers vide **EOI NO. DS-2 Hybrid seed production of maize hybrids PMH 14 and PMH-17 through public/private partnership during Rabi 2025-26 in southern India** desirous of producing hybrid seed of maize hybrids PMH 14 and PMH-17 during *Rabi* 2025-26.
- b) Interested seed growers who meet the criteria may furnish their Expression of Interest with all the necessary documents in a sealed cover along with the covering letter and quotation (Rupees per quintal) duly signed by an authorized signatory.
  - (i) Proof of expertise in hybrid seed production of maize
- c) The term of MoU will be for one season i.e. *Rabi* 2025-26

### **4. ELIGIBILITY CRITERIA**

The invitation of bids is open to all seed growers who fulfil the criteria as specified below:

- a) Must have atleast 5 years experience of maize cultivation and thorough knowledge of package of practice.
- b) Seed producer must have 3 years experience of hybrid maize seed production.
- c) The work being of specialised nature, if bids received are limited in numbers, the competent authority may relax one or more dimensions of the eligibility criteria at its discretion.

**5. TERMS OF ENGAGEMENT**

- PAU intends to produce hybrid seed of maize PMH-14 on 5 acres and PMH 17 on 10 acres in southern India during *Rabi* 2025-26.
- The seed of parental lines will be supplied to the grower(s) on cost basis.
- The individual grower must maintain the proper isolation distance (300 m) from the nearby fields of maize.
- The grower has to use the entire seed of parental lines provided to him for hybrid seed production only and cannot retain, resale or multiply these at his own. In case the grower left with some seed after finishing sowing, that seed will be the property of the university and will have to return it to the university.
- The sowing of the hybrid seed production plots should be completed up to 15<sup>th</sup> of November, 2025.
- The cost of production of processed seed including expenses on sowing, irrigation, weeding, fertilizers, harvesting, threshing, cleaning, grading, packing and transportation will be borne by the company/seed growers.
- Technical knowhow for hybrid seed production will be provided by university to the seed growers as and when required.
- The In-charge, Maize Section, Deptt of PB&G and o/o Director (Seeds) will ensure the proper inspection of the seed crop especially at the time of de-tasselling and harvesting.
- The seed producer will arrange for the processing of seed. The processed seed must qualify the minimum seed standards (pure seed (minimum) 98%, inert matter (maximum) 2%, germination (minimum) 90% and moisture (maximum) 12%. The PAU may depute its personnel to inspect the processing of seed as well as sampling of seed for testing if required.
- Transportation of graded and packed seed (in 50 kg bags) as per destination decided by Director (Seeds) will be the responsibility of the seed producer.
- The safe delivery of dispatched seed at the destination (PAU, Ludhiana) shall be the responsibility of the seed producer. Any loss or damage during transport will be to the account of seed producer.
- The seed producer shall supply graded seed, passed for germination, moisture content to PAU up to the first week of April 2026. Testing of the seed will be done

after receiving the seed and the payment will be made only if the seed meets the Indian Minimum Seed Certification Standards regarding germination and other quality traits.

- Director (Seeds) will procure the graded and packed seed on behalf of the University at his own level for sale of the seed.
- The interested seed producer may quote the supply rates in Rupees (INR) per quintal. This rate shall be only for graded and packed seed (in 50 kg bags), delivery F.O.R. at PAU, Ludhiana, which will be inclusive of all the charges viz, seed production cost, drying, grading/packing cost, storage and transportation charges, and all other miscellaneous charges.
- The graded seed having poor germination and discolouration will not be accepted and in case of rejection, the grower will be free to sell the produce at his own level.
- In case of any dispute, the Vice-Chancellor, PAU will be the final authority to settle it and the decision will be binding on both the parties.

**6. EVALUATION PROCESS**

- a) PAU will constitute an Evaluation Committee to evaluate the responses of the applicants.
- b) The Evaluation Committee constituted by PAU shall evaluate the EOI and all supporting documents & documentary evidence. The committee may seek additional documents / presentation as it deems necessary.
- c) Each of the EOI shall be evaluated to validate competence of the applicant according to the supporting documents specified in this document.
- d) In case of excessive qualifying EOI received, weightage shall be given based on the seed producers having the expertise in hybrid seed production.
- e) The decision of the Evaluation Committee in the evaluation of Expression of Interest shall be final. No further correspondence will be entertained in this regard.
- f) The Evaluation Committee reserves the right to reject any or all proposals.

**7. SUBMISSION OF EOI**

- a) The application shall be submitted in a single sealed envelope and superscripted as **EOI NO. DS-2 Hybrid seed production of maize hybrids PMH 14 and PMH-17 through public/private partnership during Rabi 2025-26 in southern India**. This envelope should contain signed hard copy of EOI proposal.
- b) No overwriting/changes is allowed in submitted EOI documents.
